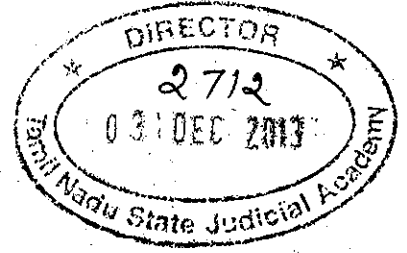

Breakfast, Lunch and dinner with Coffee and snacks will be provided at the venue.


The nominated Officers from outstations are permitted to claim T.A./D.A. in this regard, as per rules in force.
